Acceptance of Terms

Your Account

If you use the **JK Entertainment** Rental service, you represent and warrant that all information you supply to **JK Entertainment** is complete and accurate. You are solely responsible for maintaining the confidentiality of your account information, including your password, and for restricting access to your computer. You also agree not to impersonate any other person while using the **JK Entertainment** service. Prices and availability are subject to change without notice. We also reserve the right to limit quantities. Dealer orders will not be accepted without prior written permission.
